**Deadline: Applications must be received by May 15, 2019.**

The American Foundation of Savoy Orders is pleased to announce a call for applications for the 2019-2020 Savoy Orders Pigott Scholarships.

The Board of Directors of the American Foundation of Savoy Orders is pleased to present the Instruction Sheet and Application Form for the Savoy Orders Pigott Scholarships in two areas of discipline: Humanities & Fine Arts and International Studies

Three \$2,500 scholarships, based on academic excellence and financial need, will be awarded for the 2019-2020 academic year. To qualify, prospective grantees must be full time undergraduate or graduate students and have a major in the Humanities & Fine Arts or International Studies. The scholarships are available to citizens and permanent residents of the United States. Please see the scholarship guidelines for additional information.

All interested, qualified students are encouraged to apply for the scholarship.

#### **Eligibility Requirements:**

Applicants must be full time undergraduate or graduate students and have a major in the Humanities & Fine Arts or International Studies. The scholarships are available to citizens and permanent residents of the United States. Please see the scholarship guidelines for additional information.

#### **Notification:**

The American Foundation of Savoy Orders, Incorporated will notify selected 2019-2020 Savoy Orders Pigott Scholarship recipients by July 30, 2019.

**Essay:** Please attach to the application a brief essay (between 250-500 words) on how the scholarship will help you develop your academic and career goals.

**For students applying for the International Studies Scholarship**, please note that students are required to periodically attend Non-Governmental Organization (NGO) briefings at sessions relating to the Economic and Social Council of the United Nations with which the Savoy Foundation is registered as a NGO. Scholarship recipients will be required to write brief summaries for 3 meetings they attend. A Foundation representative will supervise and guide the student's activities at the United Nations. Enrollment in a college or university within reasonable proximity of the United Nations is required.

## SAVOY ORDERS PIGOTT SCHOLARSHIP GRANT GUIDELINES

Description and purpose of the Savoy Orders Pigott Scholarship. The Savoy Orders Pigott Scholarship will be awarded annually by the American Foundation of Savoy Orders Incorporated, a New York 501(c)(3) not-for-profit corporation, to U.S. students attending accredited colleges or universities. The recipient of the scholarship will receive a grant from the Foundation to apply toward tuition or related academic and living expenses. The grant will be paid in equal monthly installments throughout the academic year.

Eligibility for the scholarship. Undergraduates and graduate students who are enrolled full-time at an accredited college or university, who are permanent residents of the United States and have proven financial need and a minimum academic grade point average of 3.00 or its equivalent, will be eligible for consideration for the scholarship. Applications must be received by the Foundation by May 15<sup>th</sup> of each year and the scholarship recipient will be selected by July 30<sup>th</sup> for the Fall semester. Students who have been awarded the scholarship for one academic year may re-apply for continued support in the following academic year, but renewal is not automatic and should not be relied upon regardless of whether the student continues to qualify under applicable criteria.

Specific criteria used to select grant recipients. The grant recipient will be selected based on proven financial need, academic strengths, extracurricular involvement, an essay question (such as how will the scholarship help you develop your academic and career goals), and two letters of recommendation from academic sources.

Number of scholarships that will be made annually. Three or more undergraduate or graduate students will be chosen each academic year by the Foundation.

Amount of scholarship. The recipient will receive a scholarship from the Foundation, initially estimated to be \$2,500.00, to apply towards tuition and related academic and living expenses. The scholarship will begin in September, and payment of the grant will be made in equal monthly installments during the academic year.

Conditions imposed on the recipient to maintain the scholarship. To remain in good standing, the recipient of the scholarship must, throughout the academic year in which he or she participates in the program, be a full-time student enrolled at an accredited college or university.

Procedures for supervising the scholarship. The Foundation will provide appropriate monitoring of the students' continuing qualifications for the grants. The scholarship will be paid directly to the student. The school will provide the Foundation with confirmation that the recipient is enrolled as a full-time student in good standing throughout the academic year in which he or she participates in the program. If the terms of the award are violated, the monthly payments will cease until the violation is rectified, or cancelled, if it is not.

Selection Committee. The Selection Committee will consist of selected members of the Board of Directors of the American Foundation of Savoy Orders Incorporated. The Selection Committee's choice of candidate will be forwarded to the Foundation's Board of Directors for approval.

Disqualified Persons. Neither members of the Selection Committee, Officers, Directors and Members, if any, of and substantial contributors to, the Foundation nor their relatives shall be eligible for the scholarship. The Foundation will not provide scholarships to employees of a particular employer.

Additional Understandings. Annually, the Foundation will arrange to receive and review scholarship grant applications. The Foundation will investigate diversions of scholarship funds from their intended purposes. The Foundation will take all reasonable and appropriate steps to recover diverted scholarship funds, ensure other scholarship funds are used by a grant recipient for their intended purposes, and if not, will withhold further payments to a grant recipient until the Foundation obtains the grant recipient's assurances that future diversions will not occur and that appropriate precautions will be taken to prevent future diversions from occurring.

The Foundation will maintain all records relating to individual scholarships, including information obtained to evaluate an applicant, identify whether an applicant is a disqualified person, establish the amount and purpose of each scholarship, and establish that the Foundation monitors a grant recipient during the term of the scholarship.
